The risk of dying in bushfires: A comparative analysis of fatalities and survivors (Journal article)

Progress in Disaster Science, Vol 1, May 2019

A limitation in disaster risk reduction research is the lack of comparative analysis between those who die and those who survive in the same event. This makes it difficult to determine factors that increase or decrease the risk of dying in a disaster. In this paper, we begin to address this research gap by using published data from the 2009 'Black Saturday' bushfires in Victoria, Australia.

This report considers the role of insurance in restoring local economic activity and reducing the long-term impact of natural disasters in Australia. The analysis looks at the experience of three recent natural disasters: Cyclone Debbie, Tathra bushfires and Hobart's floods. All three disasters had a devastating effect on local communities and economic activity, and unlike previous studies, this analysis considers the economic impact of insurance payouts made to those affected.

Escape Route Index: A Spatially-Explicit Measure of Wildland Firefighter Egress Capacity (Journal article)

For wildland firefighters, the ability to efficiently evacuate the fireline is limited by terrain, vegetation, and fire conditions. To address the need for a spatially-explicit measure of egress capacity, this paper introduces the Escape Route Index (ERI).

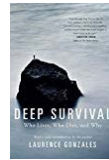

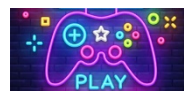

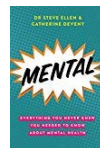
Can peat soil support a flaming wildfire? (Journal article)

By analysing Australian 2006, 2011 and 2016 Census data, we determine whether their income levels were able to recover post disaster in the short and medium term, considering demographic factors and employment sectors.

Using a statistical model of past wildfire spread to quantify and map the likelihood of fire reaching assets and prioritise fuel treatments *(Journal article)*

International Journal of Wildland Fire, Online: 9 July 2019

We present a method to quantify and map the probability of fires reaching the vicinity of assets in a wildfire-prone region, by extending a statistical fire spread model developed on historical fire patterns in the Sydney region, Australia. It calculates the mean probability of fire spreading along sample lines around assets, weights the probability according to ignition probability and also estimates the change in spread probability that fuel reduction in treatment blocks would achieve.

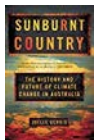

And her grazier neighbour is doing his best to ensure she does, attacking her method of burning off to repel a bushfire.
